

Dollywinks Terms and Conditions, Homing Agreement, and Conditions of Sale

Please note that all our kitten owners sign our homing agreement.

1. This contract is to be interpreted in accordance with the laws of England & the United Kingdom.
2. At the time of homing. It is agreed by both parties that the kitten is in a good health. It is recommended that the purchaser takes the kitten to a veterinary surgeon for a general health check and registration within the first 48 hours. If the kitten is found to be not as described or of poor health then under the Consumer Contracts Regulations 2014 you have the right to return the kitten to us for a full refund. Dollywinks or the breeder are not liable for any costs you have incurred for veterinary fees or returning the animal.
3. The kitten is to travel in a Pet Carrier suitable for it's size and distance travelled at all times.
4. All reasonable care should be taken for the kitten's welfare at all times. The kitten is being homed on the basis of being an indoor cat only and must not be allowed to 'free roam' outside.
5. In case of illness or accident veterinary advice must be sought immediately.
6. The kitten must not at anytime be re-homed, re-sold without the breeders' prior knowledge. In the event that the purchaser wishes to re-home the kitten the breeder reserves the right to take the kitten back or to participate in finding a suitable new home.
7. Any derogatory/ damaging comments or actions against the breeder named within this contract, or Dollywinks, either verbally or electronically i.e. email, Facebook, Forums, Twitter but not limited to, we reserve the right to refund the original purchase price and repossess the cat or kitten. We shall give you 48 hours notice of this by using every communication method we have for you. This may include Facebook, Email, Text Message, Voice Message or Recorded Postal Mail.
8. All pictures either on the website (dollywinks.co.uk) or (www.facebook.com/dollywinksUK), or emailed to you, remain the property of Dollywinks and are subject to copyright, all rights reserved. They are not to be reproduced, altered or distributed in any format without the written consent of the breeder or the copyright holder.
9. Should it be found that any of the above terms named here (3, 4, 5, and 6) are not being adhered to then the breeder reserves the right to take immediate possession of the kitten. No monies will be refunded and the purchaser will be liable for any veterinary fees for a period of 48 hours after repossession.
10. We reserve the right to take legal action against any owner who is in breach of this contract or brings the good name of the breeder or dollywinks into disrepute.

Please note that I the breeder named below reserve the right to withdraw the offer of a kitten at any time. Should this occur, all monies paid will be refunded in full, immediately.
